
### Limited Data Available on USDA Attorney Fee Claims and Payments

## 2012 & 2014 GAO reports

directed GAO to publicly available information sources. GAO found that the Forest Service was the only program agency within USDA that was able to Security and Justice Diprovide certain attorney fee data across the 11-year period. GAO reported in April 2012 that about \$16.3 million in attorney fees and costs in 241 environmental cases from fiscal years 2000 through 2010 was awarded against or settled by the Forest Service (see fig. below).

- Nationally: \$16.3 million paid, 241 cases, 2000-2010

# **Region One Background**

- June 2012 thru June 2013
- 127 timber sale projects awarded
- 31 categorically excluded from appeal
- 52 administratively appealed
  - 92% of non-CE volume
  - 93% of non-CE cruised acres
- 26 litigated (none of CE)
  - 226.5 MMBF (54%) of volume
  - 42,500 acres (68%) of cruised area



# **Case Study Approach**

- Litigated R1 projects/cases
- not random or a "representative sample"
- memorable or "high profile" cases
  - Spotted Bear River (SBR)
  - Colt Summit
  - Bozeman Municipal Watershed
  - Bussel 484
  - Little Slate

# **Litigation Cost Categories**

- FS legal costs attorney fees & payments
- FS analytical & administrative costs
- Loss of timber sale revenue
- Forgone/delayed FS work "opportunity costs"
- FS "ripple effects" changed procedures
- Other agency costs: FWS, OGC, DOJ
- Community costs economic impacts

# **Survey Methods**

- met with key FS staff to determine information needs;
- drafted questions to get required information;
- FS staff reviewed the drafts & provided feedback;
- revised the questions based on input;

 administered to personnel involved with litigation.

## Spotted Bear River (SBR) Case Study #1

- About 50,000 acres in Flathead NF
- Purpose: forest health & restoration, timber productivity, recreation
- Two associated timber sales
- Thinning, Rx burning, trailhead parking & road improvements

## **SBR Timeline**

- Scoping & NEPA began Nov. 2009
- Decision Notice Aug. 2011
- Notice of Intent Oct. 2011
- Initial Complaint Feb. 2012
- Magistrate's findings June 3, 2013
- Tin Mule sale awarded June 19, 2013
- TRO/PI filed June 20, 2013
- Rejection of PI July 2013
- Appeal to 9<sup>th</sup> Circuit Sep. 2013
- 9<sup>th</sup> Circuit to hear case April 2014
- Begin Tin Mule harvest June 2014

## **SBR Litigation Costs**

- FS legal costs/EAJA fees none to date
- FS analytical & administrative costs Over \$95,000 to date
- Lost timber sale revenue None to date
- Forgone or delayed FS work Explain
- FS "ripple effects" None identified
- FWS costs exceed \$4,500 to date
- Community costs Could exceed \$10 million

# **Litigation Impacts**



- Costs exceed EAJA fees
- In addition to NEPA costs
- Attorney costs missing
- Community economic impacts are largest \$ value
- Extend beyond specific projects being litigated
- Very difficult to quantify
